TV Mehta Charitable Foundation, Lalitaben Ramniklal Shah Homoeopathic Medical College Gardi Vidyapith Campus, Opp. Arya Club, Kalawad Road Village Anandpur, Jamnagar, Gujarat-361162 functioning since 2013 and has applied for permission. The College has submitted the Part 1 information in which the entire functional profile has been narrated. The Medical Assessment and Rating Board has examined the profile of the College as to whether the college fulfils the Minimum Essential Standards to be fulfilled as per the prevailing regulations under clause 28 of NCH Act 2020.

On careful examination of the report, the Medical Assessment and Rating Board has observed following shortfalls as per the MSR requirement.

a). Miscellaneous

- College has not enabled the Aadhaar Enabled Biometric Attendance System(AEBAS).
- Form 16 not submitted from traces portal.

b). Hospital Details

- The model case records submitted by the college are not complete with regards to the primary requirements. The presence of such patient in OPD/IPD could not be justified as per document submitted.
- It is highly essential that all cases registered in Medical College be recorded with the complete demographic details of the patient essentially contact details, postal address and diagnosis as per ICD criteria of disease diagnosis.
- All case records shall be complete in respect of case history, analysis, evaluation and repertorisation, Prescription and follow-up .All prescriptions shall be accompanied with justification for prescription.
- All case records shall be made available in the medical record room for academic purpose of students and follow up of the patient.

Considering the above observations and facilities available, Medical Assessment and Rating board has decided to issue **Conditional permission to TV Mehta Charitable Foundation, Lalitaben Ramniklal Shah Homoeopathic Medical College Gardi Vidyapith Campus, Opp. Arya Club, Kalawad Road Village Anandpur, Jamnagar, Gujarat-361162 with intake capacity of 100 seats in BHMS course and 16 seats in PG in 4 subjects namely Homoeopathic Philosophy(4), Materia Medica (4), Repertory(4), Practice of Medicine(4), for the academic year 2024-2025 .**

All deficiencies noticed shall be verified within a period of one month and compliance report shall be submitted for verification

All admissions shall be made from NEET/AIAPGET qualified candidates only. It is further informed that minimum 15% of undergraduate seats and 15% of postgraduate seats of the intake capacity of 100 UG seats and 16 PG seats shall be treated as All India Quota .The counseling for seats under All India Quota shall be conducted by respective counseling authority as designated by Central Government /NCH for the A.Y 2024-25 and counseling for the remaining 85% seats or as the case may be, shall be conducted by the concerned counseling Authority of the State/UT

The category wise list of the selected candidates may be informed to the Medical Assessment and Rating Board for Homoeopathy after the process of admission is completed. Any admissions carried out other than NEET/AIAPGET qualified students will not be approved by the Medical Assessment and Rating Board.


Permission to the college can be withdrawn or denied in the subsequent year if college is found deficient to compliance to MSR 2013 anytime during the academic year.
