
MEMORANDUM
OF
UNDERSTANDING

Between

Jyoti CNC Automation Limited

and

Gardi Vidyapith



1. Preamble

This Memorandum of Understanding ("MoU") is made and entered into on this 15th day of September 2025, by and between:

- Jyoti CNC Automation Limited**, a company incorporated under the laws of India, having its registered office at Plot No. 2839, Lodhika GIDC, Village Metoda, Rajkot – 360 021, Gujarat, India (hereinafter referred to as "**Jyoti**", which expression shall, unless repugnant to the context or meaning thereof, include its successors and permitted assigns); and
- Gardi Vidyapith**, having its principal office at [insert full address] (hereinafter referred to as the "**Institution**", which expression shall, unless repugnant to the context or meaning thereof, include its successors and permitted assigns).

Together referred to as the "**Parties**" and individually as a "**Party**".

2. Non-Commercial & Binding Nature

This MoU is non-commercial in nature. It is expressly agreed that this MoU is non-binding and does not create any legal or financial obligations between the Parties, except for the provisions relating to: **safety & compliance, confidentiality & data protection, intellectual property, publicity & use of logo, liability & expenses, governing law & jurisdiction, notices, and general boilerplate clauses**, which shall be legally binding on the Parties.

3. Scope of Collaboration

The Parties agree to collaborate in good faith for academic and research engagement, which may include but is not limited to:

- Guest lectures, workshops, and knowledge exchange.
- Industrial visits (observational only).
- Internship and training opportunities (subject to prior written approval, supervision, and safety protocols).
- Collaborative research or academic projects (requiring a separate agreement as necessary).

Any proposed setup of a Centre of Excellence, financial commitments, provision of equipment, software, or significant resources shall be subject to execution of a separate definitive agreement.

4. Safety & Compliance

- The Institution shall ensure that its students and participants comply with all safety and environmental health standards, including the use of PPE and adherence to supervision and discipline protocols.
- Where applicable, parental/guardian consent shall be obtained by the Institution.
- The Institution shall be solely responsible for ensuring appropriate medical/accident insurance coverage for its students/participants.

- Both Parties shall comply with all applicable laws and regulations in relation to the activities contemplated under this MoU.

5. Confidentiality & Data Protection

- Each Party shall maintain the confidentiality of information disclosed under this MoU and shall not disclose it to third parties without prior written consent, except where:
 - (a) the information is in the public domain.
 - (b) it was independently developed without reference to the other Party's confidential information. or
 - (c) it was lawfully obtained from a third party.
- Student-related data shall be collected and used only with proper consent and shall be safeguarded with adequate security measures.
- Confidentiality obligations shall survive for a period of **three (3) years** post-termination of this MoU.
- Disclosure of information/materials does not grant any implied license.

6. Intellectual Property

- Each Party shall retain ownership of its pre-existing intellectual property.
- Materials shared by Jyoti shall only be used internally by the Institution for academic purposes and shall not be redistributed without prior written consent.
- Any new intellectual property generated through joint projects shall be governed by a separate written agreement.

7. Publicity & Use of Logo

Neither Party shall use the other Party's name, logo, or make any public announcement regarding this MoU without prior written consent of the other Party.

8. Term, Termination & Survival

- This MoU shall remain valid for a period of **three (3) years from the Effective Date**.
- Either Party may terminate this MoU for convenience by **giving 30 (thirty) days' prior written notice**.
- Immediate termination shall be permitted in cases of breach, legal/regulatory requirements, or misconduct.
- Provisions relating to confidentiality, intellectual property, liability, governing law, notices, and other binding clauses shall survive termination or expiry of this MoU.

9. Liability & Expenses

- Each Party shall bear its own costs and expenses in relation to this MoU, unless otherwise mutually agreed in writing.
- Neither Party shall be liable to the other for any indirect, incidental, or consequential damages arising out of or in connection with this MoU.



10. Governing Law & Jurisdiction

This MoU shall be governed by and construed in accordance with the laws of India. Courts at Rajkot, Gujarat shall have exclusive jurisdiction over any disputes arising under this MoU.

11. Notices & Coordination

- All notices under this MoU shall be made in writing and sent by registered post, courier, or email (with acknowledgment of receipt) to the addresses set out above.
- Each Party shall designate a coordinator responsible for scheduling and overseeing activities under this MoU.

12. General Provisions

- **Force Majeure:** Neither Party shall be liable for failure to perform obligations due to events beyond reasonable control.
- **Entire Agreement:** This MoU constitutes the entire understanding between the Parties regarding the subject matter and supersedes any prior discussions.
- **Amendments:** This MoU may only be amended in writing with the consent of both Parties.
- **Counterparts / E-Signatures:** This MoU may be executed in counterparts, including electronically, each of which shall be deemed an original.
- **No Agency/Partnership:** Nothing in this MoU shall be construed as creating a partnership, agency, or employment relationship between the Parties.

13. Execution
